Draft Naturopathic Therapies Regulation

Standard of practice regarding therapies

- 1. It is a standard of practice of the profession that Naturopaths shall only use therapies that:
 - a. Have been demonstrated to be effective and for which they have the knowledge, skill and judgement to use,
 - b. Treat symptoms, complaints or conditions that are within the scope of practice,
 - c. Are supported by sound clinical judgment,
 - d. Are informed by evidence and scientific reasoning to a degree that is proportionate to the risks to the patient associated with the therapy, and
 - e. Have potential benefits which outweigh the risks, taking into consideration:
 - i. The health status of the patient
 - ii. The evidence and reasoning regarding the efficacy of the treatment for the patient's symptoms, complaints or condition,
 - iii. The potential for harm to the patient due to factors including the nature of the therapy, the potential interaction with other therapies and treatments the patient may be undergoing, other therapies available from members of the profession and members of other regulated health professions and whether other therapies will be provided concurrently, and
 - f. The patient has given informed consent to use.

Therapies authorized for use by NDs

- 2. Subject to the provisions of section 1 and without limiting the generality of the foregoing, registrants are authorized to perform the following naturopathic therapies,

The Use of Prescribed Therapies

3. Notwithstanding section 1, the following conditions govern the use of the prescribed therapies set out in section 2,

Therapy	Conditions/Limitations on Use
i. Diathermy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.
ii. Hyperbaric oxygen therapy,	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada. Limited for use to
	the 14 conditions identified by Health Canada.
iii. Immune-supportive therapy,	The registrant may only use natural health products authorized for
	sale and distribution in Canada by Health Canada.
iv. Inhalation therapy	The registrant must have met the Standard of Practice for
	Prescribing as set out in section 5(4) of the General Regulation and
	may only inject substances set out in Table 1 of the General
	Regulation and in accordance with the specified limitations set out
	therein.
v. Injection therapy	The registrant must have met the Standard of Practice for
	Prescribing as set out in section 5(4) of the General Regulation and

	may only inject substances set out in Table 2 of the General
	Regulation and in accordance with the specified route of
	administration and limitations set out therein.
vi. IVIT therapy	The registrant must have met the Standard of Practice for
	Prescribing as set out in section 5(4) of the General Regulation and
	must have met the Standard of Practice for IVIT as set out in section
	5(5) of the General Regulation and may only administer by IVIT
	substances set out in Table 2 of the General Regulation and in
	accordance with the specified route of administration and
	limitations set out therein.
vii. Light therapy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.
viii. Naturopathic manipulation	A registrant may only move the thoracic, lumbar and sacral and
	cervical joints of the spine provided none of the contraindications
	set out in section 6(3) of the General Regulation exist.
ix. Prescription therapy	The registrant must have met the Standard of Practice for
	Prescribing as set out in section 5(4) of the General Regulation and
	may only prescribe, dispense, compound or sell drugs set out in
	Tables 3, 4, 5 and 6 respectively and in accordance with the
	limitations set out therein.
x. Rehydration therapy	If delivering this therapy by injection or intravenous infusion
	therapy, the use of this therapy is subject to the conditions of use
	set out in this section for those therapies.
xi. TENS therapy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.
xii. Ultrasound therapy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.
xiii. Ultraviolet therapy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.
xiv. Waon therapy	The registrant must deliver this therapy using a device that is
	authorized for sale in Canada by Health Canada.

Therapies prohibited

- 4. Notwithstanding section 1 above, the following therapies are prohibited for use by registrants, except when performed under a delegation from a member of a self-governing profession set out in Schedule 1 of the *Regulated Health Professions Act, 1991* authorized to perform the therapy and in accordance with Part III of the General Regulation:
 - i. Allergy immunotherapy Advanced,
 - ii. Art therapy,
 - iii. Androgen replacement therapy,
 - iv. Aurotherapy,
 - v. Autologous immune enhancement therapy,
 - vi. Cardiac resynchronization therapy,
 - vii. Cell therapy,
 - viii. Cobalt therapy,

- ix. Craniosacral therapy,
- x. Electroconvulsive therapy,
- xi. Electromagnetic therapy,
- xii. Electron therapy,
- xiii. Energy therapy,
- xiv. Epigenetic therapy, including gene therapy,
- xv. Extracorporeal shockwave therapy,
- xvi. Fecal microbiota transplant therapy,
- xvii. Hormone / Anti-hormone therapy, except bio-identical hormone therapy,
- xviii. Helminthic therapy,
- xix. Hyperthermia therapy,
- xx. Ichthyotherapy,
- xxi. Immunosuppressive therapy,
- xxii. Injection therapies using unapproved substances not appearing on Table 2 to the General Regulation, and without limiting the foregoing, including:
 - a. Blood irradiation therapy,
 - b. Cell therapy,

 - f. Intravenous immunoglobulin therapy
